2. You hereby irrevocably and unconditionally:
  - 2.1 acknowledge that as the author of the Photograph and any recordings made of you pursuant to this Agreement, the Liberal Democrats shall be the sole owner of all rights, title and interest therein (including copyright) with the absolute and exclusive right to make such use of the Photograph (including all subsidiary, derivative and ancillary rights therein) and any and all rights, licenses, privileges and properties conveyed herein as the Liberal Democrats shall think fit at our absolute discretion;
  - 2.2 assign to the Liberal Democrats with full title guarantee (and where the assignment is of copyright or performers' property rights, by way of assignment of present and future copyright or performers' property rights) all right, title and interest of whatsoever nature (including all copyright and performers' property rights and any and all rental and lending rights), throughout the universe, whether vested or contingent, in and to the Photograph for the Liberal Democrats to hold the same absolutely, for the full period of those rights wherever subsisting or acquired, and all renewals, reversions, revivals and extensions thereof, and thereafter (insofar as you are or may become able to do so); and
  - 2.3 grant to the Liberal Democrats all rights, consents and waivers which the Liberal Democrats may require to make and permit full use of the Photograph and you acknowledge that the Liberal Democrats shall be entitled to use the Photograph as may be required without any restriction whatsoever including the right to edit or modify the Photograph in any and all media now known or hereafter devised in any and all versions worldwide, in perpetuity; in particular, you irrevocably and unconditionally waive all so-called "moral rights", "droit moral" and analogous rights throughout the world.
3. You do not object to the Liberal Democrats storing copies of the Photograph for as long as necessary to fulfil the Specified Purposes or to us storing your contact details on our database in case we need to contact you.

Democrats, 66 Buckingham Gate, London, SW1E 6AU. This will not affect the lawfulness of any processing carried out by the Liberal Democrats before you withdraw your consent.

5. The Liberal Democrats are the data controller and responsible for the personal data comprising the Photograph and your contact details.
6. The Liberal Democrats will:
  - 6.1 ensure that we comply with the requirements of all legislation and regulatory requirements in force from time to time relating to the use of the Photograph and your contact details; and
  - 6.2 process the Photograph and your contact details in accordance with the privacy notice attached as Schedule 1 to this Agreement, receipt of which you acknowledge by signing this Agreement.
7. This Agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation) shall be governed by and construed in accordance with the law of England and Wales.
8. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this Agreement or its subject matter or formation.
